### **OVERVIEW**

Dr. Jenner is the principal investigator for a number of ongoing RCTs, quasi-experimental, and observational studies. He has experience using a variety of econometric analytical methods to assess the effects of interventions and program-related change, including multivariate linear and logistic regression, longitudinal, multi-level and mixed-effects modeling, time-series analysis, and survival analysis.
